

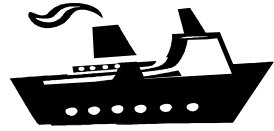

## CORPORATE AGREEMENT APPLICATION

This Agreement, which governs the terms and conditions of the use of the services of

For purposes of this agreement, “services” are defined as any and all car assigns(s) either now or in the future. By using the services of Seaman Radio Dispatchers, Inc. You confirm your acceptance of, and agree to be bound by this agreement.

## CHARGES

1. You agree to pay all charges for your use of the services of Seaman Radio Dispatchers, Inc. at the prices then in effect, Seaman reserves the right to change prices or institute new charges for its services, you are responsible for regularly reviewing, obtaining and confirming such pricing information. Continued use of the services of Seaman Radio Dispatchers, Inc. non-termination of your account of your account after changes are posted constitutes your acceptance of the prices as charged.
